Loan Facilities:

The company has the following unsecured loan facilities with the following terms:

- 1) A\$800,000 working capital facility provided by Mr Stephen Copulos (former non-executive Chairman) and Mr Andrew Richards (non-executive Chairman); repayable by 30 June 2021. Interest rate is 10.0% per annum with accrued capitalised interest is A\$91,995;
- 2) A\$400,000 of unsecured working capital facilities from entities related to the Copulos and Retzos Group's. The working capital facilities are to be repaid from the proceeds of the Entitlements Issue. Should the working capital facilities not be repaid, at the option of the lenders the working capital facilities may convert into equity at the lower of A\$0.003 per share or the next capital raising price. The working capital facility is interest free unless the facility is not repaid out of the proceeds of the Entitlement Issue.

Convertible Notes

The convertible notes have been issued in a series of tranches, each with similar terms including an interest rate of 10% p.a., unsecured, and convertible at the election of the convertible note holder. The conversion share price varies per tranche of issue and ranges from A\$0.01 - A\$0.015 per share and mature between 30 June 2020 and 27 August 2020.

1. Does the entity expect that it will continue to have the current level of net operating cash flows for the time being and, if not, why not?

Answer: During Q2 2020 the entity expects to have similar level of net operating cashflows due to the Mexican Government decree issued on 6 April 2020 deeming mining a non-essential activity which will be required to suspend production until the second half of May 2020.

2. Has the entity taken any steps, or does it propose to take any steps, to raise further cash to fund its operations and, if so, what are those steps and how likely does it believe that they will be successful?

Answer: The Company announced a new fully underwritten Entitlements Issue on 23 April 2020, to raise A\$1.725 million before costs of the offer. In addition, the Company is actively pursuing the refund of outstanding VAT due to the Company from the Mexican Government.

3. Does the entity expect to be able to continue its operations and to meet its business objectives and, if so, on what basis?

Answer: Yes the Company will be able to continue its operations based on the resumption of mining activities in the second half of May 2020 and the fully underwritten Entitlement Issue to raise A\$1.725 million before costs of the offer.
